

Let's Set the Record Straight

There seems to be a bit of confusion on where VASI stands on important airport issues. Some of this confusion is caused by the never ending attacks on VASI Board members and VASI as an organization as well as the orchestrated distortions of information and facts about the airport. VASI is an advocate for a safe, modern airport with up to date facilities. VASI does not advocate a larger airport. VASI does support the Airport Advisory Board recommended Master Plan Update. VASI does not support efforts to reduce runway length or change the Airport Reference Code (ARC). All the hard data supports and reinforces VNC as an ARC CII facility. FAA officials have indicated their rejection of both of these efforts to reduce runway length or change the ARC. The VASI position on a control tower is straight forward - VASI supports a study on a tower – not a tower- a study. The study data (which may take two years to collect/ develop) will speak for itself. Only after an FAA sanctioned study is completed can any recommendation, pro or con, be made on a tower for VNC. VASI also supports a Part 150 noise study. This study would also

take two years to complete. The noise study would clearly define any noise impacts. It would also provide a true operational count and help define potential capacity limits as well. One of the most important results of a Part 150 noise study is the data provided supports grant requests for noise mitigation projects. Study results are also required before the city could impose any enforceable operational limitations for perceived noise. (This was explained to City Council and then Council eliminated the Part 150 noise study from the JACIP – figure that one out. Why the Noise Nazis think this is OK is a mystery of life). VASI supports additional T-Hangar Buildings, both to meet current demand and replace older city hangars. Ts help everyone and provide needed revenue to maintain the airport. The Ts VASI supports will not increase capacity they just meet existing needs. VASI supports total surface rebuild/ repair (other than 13/31). Clearly showing age and past neglect the taxiways, tie-down area, and apron need serious attention. The completed engineering studies provide the data (hard data) that mandates these repairs. Actual tie down spaces would be reduced once this work was completed. There are

other infrastructure needs that should be met but these are the big ones. AWOS upgrade for example. Operational requirements for GPS approaches are so clearly safety evident for landing airplanes and the nearby neighborhoods it is hard to believe the city does not want them. VASI supports the updated Fly Friendly Program (which was rejected by council, more curious by the minute)! As for all of us: remem-

ber when departing 4/22 maintain runway heading, climb out at Vy and depart at TPA. Departing 13/31 maintain runway heading, climb out at Vy, sidestep toward Gulf at 500 feet AGL, depart at TPA. Now these are just some of the VASI positions and most of this is airport facility related. Operational, security and access positions will be covered in future articles. If you have a concern, please provide feedback so it can be addressed.

T-Hangars

Editors Note: The following data along with a series of photos of the poor condition of some of the T- hangars, taxiways, tie-down area and wind Tee were provided to the City Council Members while they considered the Joint Automated Capital Improvement Plan. We recommend inclusion in near term of construction of five 14 unit T building equivalents (70 units) in the JACIP. We also recommend all future T- Hangar construction be enhanced one door construction. T-Hangar construction will not attract more aircraft; the planes and demand are here now. Airport construction of revenue enhancing projects will reverse poor past management practices, provide capital for projects to meet community needs, improve airport security, help protect the environment, minimize the need for airport property development, protect aircraft from harm and boost the local economy. T- Hangars are financed with FDOT 80/20 Grants. A \$ 1,000,000 FDOT grant requires a \$200,000 investment from the airport reserve fund. That fund investment is recovered in less than four years. The enhanced t-hangar revenue stream should be targeted against airport projects important to the community but not grant eligible. Examples include: Landscaping along Airport Avenue, improving property by removing Pepper Plants, and perhaps most importantly, providing current operating revenue to hire "ops personnel". Current City T-Hangars 144 x \$275 x12 = \$475,200; Sales Tax 7% = \$33,264 1% to City. *Enhanced (new) T-Hangar with one piece windproof door & two tier rental programs:. One 14 unit building: 14 x 305 x 12 = \$ 51,240 (3) 153,720 (5) 256,200 Sales Tax 7% 1% to City = \$3,586 (3) \$10,760 (5) \$17,934. Older Ts will need to be replaced within the mid-term. They should be replaced with the enhanced Ts. Two of three privately held T-Hangar building leases with 26 rented hangar slots will expire in less than three years and will probably revert back to the airport. One of these buildings could be torn down, the second, based on a cost analysis/ engineering survey may suffer the same fate. Current demand for 48 Ts+26 =74 Ts x *305 = \$ 270,840 plus tax. Reduce that 74 to 42 or 3 Ts and that's still \$153,720 per year of new revenue.

SAFETY & FLY FRIENDLY

Storm Capital of the World: Popup afternoon storms and mid-day cloud buildup make for bumpy rides and wild adventures. Visit the AOPA Safety Foundation web site for quick reviews on weather, use you Mark I eye balls to detect storms and try to fly early.

When in the pattern, keep your head up and look out – remember the right of way is something you give up not take. Spacing can be a real issue – if the pattern is packed, turn away for five minutes or so and then return – it will reduce the stress and give you a little more stick time.

Runway Selection: During a Wings Program on operations at non-towered airports, the factors used to select a departure runway were reviewed. Wind Direction and speed, time of day, slope of runway, obstacles, weather, aircraft performance and pilot qualifications were all considered. The need for situational awareness was stressed. Consider Runway 22 – departing during the day or departing at night. Departing at night – how dark is dark (moonlight, starlight, no light, haze, or severe clear)? Why not depart on 31 or 4 and have solid visual orientation for that takeoff? Remind yourself wind direction is not the only factor for a safe takeoff – take your time and make the thoughtful and safe choice not the fast choice.



The Joint Automated Capital Improvements Program (JACIP) is a companion to the Airport Master Plan (MP) The MP looks at airport plans and needs based on a number of factors including aging facilities in need of rehabilitation and projections for the airport over a long term horizon. The JACIP lists those capital projects. A project not included in JACIP will not get funding. Below is a list of items that the City Council deleted from the JACIP. The deletions make little sense. After hours and hours and much wrangling the Council did approve some projects and that list is on the next page.





These days with the rising cost of fuel it's for a greasy burger but a very nice day trip continuously inhabited city in America.
